

## Patient Information and Data Consent Form

\_\_\_\_\_ **[name of legal entity operating the coordination centre to be added]** (in the following “FMC” or “we”) operates the coordination centre based in \_\_\_\_\_ **[country of coordination centre to be added]** and is responsible for the collection, processing and use of personal data in context with the coordination of dialysis treatments at holiday destinations of a patient (in the following “Holiday Dialysis”). FMC attaches great importance to the protection of personal data and collects, processes and uses personal data exclusively in accordance with the following principles:

### Collection of personal data

#### Contact details

In order to communicate with you and to discuss the details of your Holiday Dialysis, we collect your contact details (name, country of origin, email address, and phone number) when you contact us for the first time (via phone, email or online at [www.nephrocare.com](http://www.nephrocare.com) or **[URL of local website to be added]**).

If we collect the above mentioned data via an online form, the relevant website may be operated by another legal entity within the Fresenius Medical Care group of companies as named in the legal notice on the website used. In such case the website operator processes your data on our behalf and in strict accordance with our instructions **[sofern noch nicht geschehen, sind hierfür noch entsprechende Vereinbarungen zur Auftragsdatenverarbeitung nach jeweils lokalem Recht der Koordinierungsstelle abzuschließen]**.

#### Information on your holiday trip and dialysis times

After we received a signed copy of this consent form, in order to start coordinating your Holiday Dialysis in accordance with your expectation and needs, we collect details on the holiday trip you intend (destination and period of time) and the requested dialysis times and frequency.

#### Medical and health information

Furthermore, we collect medical and health information related to your person, usually by asking the physician treating you at your home dialysis centre (in the following “Home Physician”) to complete the attached “Holiday Dialysis Request” (in the following “Holiday Dialysis Request Form”).

Should your holiday destination be located in the same country as your home dialysis centre, instead of using the Holiday Dialysis Request Form, we may ask the physician at

your holiday dialysis centre to access the medical and health information required via our electronic therapy information system “EuCliD 5”, however, only to the extent you provided explicit consent to the collection, processing and use of your personal data in context with EuCliD 5.

#### **Use of personal data**

We collect, process and use your personal data mentioned above (0) exclusively for the coordination of your Holiday Dialysis.

#### **Access and transfer of personal data**

##### **Transfer to dialysis centres at your holiday destination**

In the beginning of that coordination process, we evaluate the availability of potential dialysis centres at your holiday destination. For this purpose, we may transfer your contact details and information on your planned holiday trip as well as requested dialysis times and frequency to various potential dialysis centres at your holiday destination.

Once one dialysis centre at your holiday destination has confirmed availability and was approved by you, we will transfer all data collected by you or by your Home Physician to such dialysis centre at your holiday destination in order to enable them to efficiently prepare your Holiday Dialysis.

##### **Transfer of data to an Alternative Coordination Centre**

Furthermore, if and to the extent, according to our assessment, assistance or takeover of another coordination centre within the Fresenius Medical Care group of companies (in the following “Alternative Coordination Centre”) is required or helpful in context with organising your Holiday Dialysis, we may at any time transfer your personal data to such other coordination centre. A list of coordination centres can be accessed on the website \_\_\_\_\_.

##### **Transfer of data outside the EU/EEA**

Should your holiday destination and/or the Alternative Coordination Centre be based in a country outside the EU/EEA (in the following “Third Country”), your data will be transferred to and processed in such third country. Such Third Country may not provide for an adequate level of data protection which is similar to the level of data protection granted in the EU/EEA. Instead, in such Third Country, the legal protection of personal data may not be equivalent, in particular in terms of the data subjects' rights, the purpose limitation for data processing operations, the applicability of the necessity principle as well as potential governmental access powers.

**Data security**

We take appropriate technical and organizational measures to protect your personal data stored in our IT systems against the loss, destruction, unauthorized access, amendment or dissemination.

**Right to information and correction, deletion or blocking of personal data**

You have the right to receive, free of charge, information about the data which has been stored in relation to your person and, if applicable, the right to have these data corrected, blocked or deleted. **Right to withdraw consents**
